

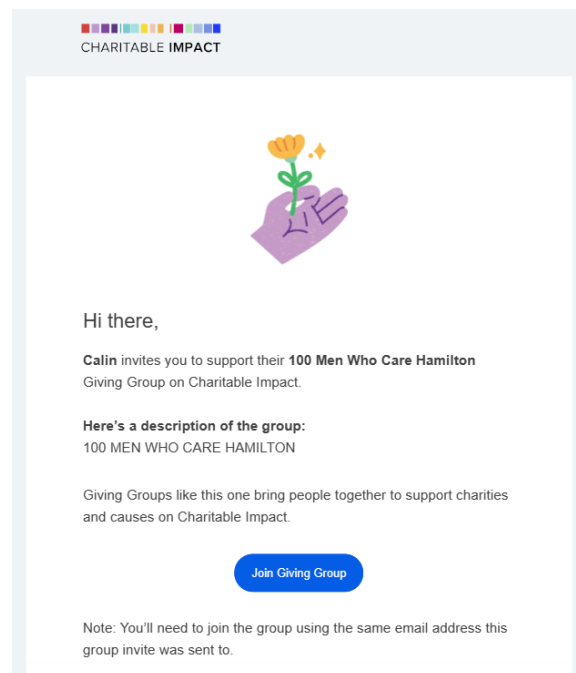


CHARITABLE IMPACT

Signing up for Charitable Impact

Charitable Impact is a website that makes giving for groups like ours possible. It has low fees (less than 3%) and automates the tax receipt process so you don't have to worry.

You will soon receive an email invitation to join the 100 Men who Care Giving Group through the website Charitable Impact. This is a legitimate email invitation. Please check your spam or junk folders for the invitation if you are not seeing it in your inbox.

- Create an account.
- You'll be able to join the 100 Men giving group once you've registered and verified your email.
- Giving money to the Giving Group is easy:
 - After we decide on a charity, head over to the Giving Group profile page (<https://my.charitableimpact.com/groups/100-men-who-care-hamilton>) and click the "Give" button in the top right corner.
 - Select the amount you want to donate (custom amounts are accepted, too).
 - If you do not have money in your Impact Account (your personal money account with Charitable Impact) you'll see this:


- Click on "reload" to add money to your account via one of the payment methods. Ensure you include your tax recipient information. CI only accepts credit card and credit debit cards (with Visa or Mastercard logos).
- Include a message or a note, and click Review at the bottom of the page.
- Review your donation information and confirm your donation.
- If you selected to share your information with the group, your activity will be seen on the profile page of the 100 Men page. You can select to simply inform the group that you donated, the donation amount, or donate anonymously.
